SQP's Care Coordination Team consists of a Social Worker, Care Expediter, Home Health Coordinator (RN), Diabetes Educator, and Data Analyst. Consider this team an extension of your office staff. Their services include: data analytics on your specific practice, your high risk patients, referral patterns, utilization of non-SQP facilities and comparisons to normative data, scheduling office visits for specialists/PCPS, home health coordination, diabetes education, and social work (community resources, support groups, noncompliant patients, social support, education, and transportation). **Quality Data Registry:** We are in the process of creating a quality data registry for each PCP to upload patient data on pertaining to the Horizon contract quality metrics. Be on the lookout for instructions for how to utilize the registry. This data registry will give us a baseline to where we stand with quality metric scoring for 2015 shared savings. As a reminder, below are the Horizon contract quality metrics:

**Clinical Process**: Pneumonia vaccination status for older adults, breast cancer screening, colorectal cancer screening, and cholesterol mgmt. for adults with cardiovascular disease

Clinical Outcomes: Diabetes: LDL-screening & diabetes - HbA1c testing

**Clinical Measures:** Comprehensive diabetes care – HbA1c control (<8%), comprehensive diabetes care - LDL-C control (LDL-C<100 mg/dL), comprehensive diabetes care – blood pressure control (<140/90)

Patient Experience: ACO Survey: getting needed care, getting care quickly, and an 8-10 rating of personal doctor

*Primary Care Physicians Increased Rates for E&M Codes:* PCPS-If you have submitted your signed rate letter back to Horizon, you should be getting reimbursed 90% for E/M codes 99213, 99214, 99215, 99395, and 99396. If you submitted your letter and have not seen the fee bump, please call Laura Mateer, Provider Relations, at 653-3500 x2405.
